

A National Community of Practice: Advancing Community-Engaged Learning Across Higher Education

A National Seminar Series
For Administrators and Faculty in the Bonner Network

Overview

The Bonner Foundation is pleased to announce a special opportunity for rising national leaders in the community engagement field. Through a series of web-based seminars, participants will engage with cutting-edge theory and discuss its application and practice at colleges and universities around the country.

Designed as a learning community for community engaged scholars (including faculty and administrators), this series is intended to advance the knowledge of participating practitioners in their own course design, facilitation of community partnerships, teaching and mentoring of students, and work on institutional change. By participating in a monthly series, participants will have the opportunity to wrestle with, apply, and refine ideas as they implement them within their own teaching, learning, scholarship, and programs. At the same time, through the Community of Practice, participants will produce new knowledge to shape the field.

By the end, each participant will apply their learning through the series to produce an artifact, which may include a new course, article, strategic plan, institutional policy, etc. The Bonner Foundation will publish participants' work in a scholarly volume and a compendium of resource materials for the field.

Objectives

- Learn, apply, and refine key ideas and theories from the field of community and civic engagement.
- Engage in rich dialogue and problem-solving with a group of peers and field leaders from across a national network.
- Apply learning to advance one's own career, institutional priorities, and the field of community engaged learning.

Enrollment and Expectations

The Bonner Foundation seeks 15-20 individuals who can commit to be a part of this Community of Practice throughout the 2020-2021 year. The commitment involves:

- Reading and preparing for nine monthly seminars (which will be scheduled in advance for all to participate);
- Attending and participating in discussion during nine monthly seminars; and
- Creating and implementing a self-designed project to advance CEL in one's own work or campus context (which may be a course, article, strategic plan, institutional policy, etc.)

Benefits of Participating

The Bonner Foundation seeks to use this opportunity to advance the careers and leadership of the individuals who participate, as well as their work on campus. Benefits will include:

- A public profile (photo, biography, and recognition of work) as a Community-Engaged Learning Leader on the Bonner Foundation's website and printed materials
- At least one professional coaching conversation with a more senior or experienced leader from another institution or organization in the field
- Recognition as a part of a national fellowship program and a formal endorsement of one's work on LinkedIn
- The opportunity to reflect on, write about, and publish one's work in a volume and compendium
- Professional advancement opportunities, through connecting with a variety of leaders in the national field of community engagement (including individuals in senior leadership positions at respected civically-focused organizations)
- A stipend of \$200, at the completion of your project that will be included in the Bonner Foundation published compendium

Format

The format for participating in this national fellowship will be fairly simple. Participants will be a part of a private webinar within the Bonner Learning Community, an online platform, where they can post ideas and questions, exchange information, and engage with each other. Each month, participants will join a 90-120 minute webinar where they discuss readings, case studies, research, and their application of these concepts in their own work. Working with instructors, each participant will identify a knowledge creation project (course, article, policy, etc.) that they work on and complete by July 2021.

Monthly Topics (October 2020 to June 2021)

This web-based discussion series will generally be held on the second or third Wednesday of each month from 3:00 to 4:00 or 4:30 pm EST. Below is an overview of dates and topics, recognizing there may be shifts due to speaker availability.
